Executive Function Skills in Elementary Aged Children	Sarah Ward, M.S., CCC-SLP
This is a practical strategies lecture! Learn it today and implement it tomorrow! What skills do students need to learn to be organized and successfully manage their own time and tasks in the classroom? This workshop will provide practical, hands-on strategies to develop students' executive function skills for success in school. The term 'Executive Function' is used to describe the skill set required for setting goals, carrying out organized steps, and modifying a plan to complete a task successfully, all of which are vital for academic and social success in elementary school. You will learn the 360 Thinking Model and gain a new understanding of how students develop independent executive function skills. Learn new techniques to teach students to independently: develop and use self-talk, stop and read the room, transition within and between tasks, initiate and complete tasks within allotted time frames, internally see and sense the passage of time, 'Be a Beat Ahead', follow routines and be ready for expected activities, and organize themselves and their materials for tasks, activities and homework. Beginners and advanced participants will learn and practice these strategies to improve students' awareness, working memory, hindsight and forethought skills, impulse control, cognitive flexibility, organization, and time/task management. SLPs & School Psychologists Joining Forces: Collaborative Assessment, LD Identification, and Intervention Development

This entertaining and informative presentation will show how school psychologists and speech pathologists can adopt the Cattell Horn Carroll (CHC) assessment framework so that they may produce a single comprehensive evaluation. Through this structured collaboration more precise diagnoses and interventions can be developed. Further, this approach can reduce evaluation time by one hour per child. Common assessment batteries used by these professionals (such as the CELF, WISC, WJ, TAPS, TOLD) will be reviewed to identify the specific cognitive construct they measure, the cultural and linguistic demands of the various subtests, and how to reduce over-testing. Specific researched based interventions that may be connected to cognitive profiles will also be reviewed. Finally, sample evaluations will be distributed and discussed.

An Integrative Approach to Stuttering

This presentation, from the perspective of an SLP and Person Who Stutters (PWS), will provide treatment strategies that address the social, emotional and behavioral aspects of stuttering for children and adolescents.

Executive Function Skills in Middle & High School

As SLPs, Developmentally, children learn to control their ability to preimagine (think) and reflect on outcomes before they impulsively react. This is one reason teens can have difficulty imagining the future consequences of their actions, resisting typical teen pressures and managing their time. Thus, they are more likely to procrastinate on tasks during the teen years. It is difficult to forego immediate gratification in the interest of long term gain and motivate oneself to initiate a task if you cannot imagine what that long term gain looks like or the emotions you might experience. Exactly how far into the future an adolescent can see is developmental in nature. Called the 'temporal horizon', teens can imagine about 2 to 3 days in the future. Hence, contemplating and planning for long term projects, which fall outside their developmental temporal window, is challenging. The temporal horizon is linked to one's sense of space or spatial capacity since moving from space to space over the course of a day (i.e. school to home, home to soccer practice, etc.) takes time. To develop or rehabilitate EF skills, a student must then learn and repeatedly practice how to stop, to see the future, use self-talk to describe the future and their future actions, to feel the future, and mentally 'play' with the future so as to effectively "plan and go" towards that future. 360 Thinking is an innovative model of executive function skills that provides a new perspective for understanding and supporting executive function skills in educational and home settings. Phonological Complexity Principles: Promoting Efficient	Jennifer Taps Richard, M.A., CCC-SLP

efficient changes in a child's phonological system (rather than one sound at a time). Attendees will learn about linguistic universals that facilitate maximal changes in both treated and untreated sounds, which result in significant gains in overall intelligibility in the least amount of time for children with phonological disorders. In particular, powerful research and anecdotal evidence about teaching complex	
clusters will be shared, along with examples of system-wide changes that occurred for several preschool and school-age students in San Diego Unified School District. Furthermore, SLPs will apply these principles when selecting treatment targets for children featured in two case studies: a young child with a phonological disorder and a school-age child with several later-developing singletons in error. After this session, SLPs may access additional resources for both	
assessment and treatment.
